DUST, SMOKE AND FUMES FROM HEAVY METALS

As a part of our yearly activities, in cooperation with the NOGEPA Workgroup, we are proud to present the latest addition in the HSElife NL Health, Safety and Environment items library: DUST, SMOKE AND FUMES FROM HEAVY METALS!

Metals are also used in various products, from jewelry to paint. In this document we look in particular at chromium-VI, lead and cadmium. These metals occur in an industrial working environment where they can cause health problems. Always look at the specific risks of the heavy metals that will be used.

DUST, SMOKE AND FUMES

In almost every industrial working environment, dust, smoke and fumes can be generated by processes such as cold metalworking, hot work (welding, cutting and grinding) and surface machining (blasting, sanding, grinding and coating). Even loosening bolts containing heavy metals can cause health risks.

INCREASE AWARENESS, DISCOVER HAZARDS

There is no better way to bring a new HSE item to the attention than to get started with it! Preferably for a couple of weeks to really give the item the attention it deserves.

The **Action Focus** allows you to zoom in on the specific safety aspects related to working with DUST, SMOKE AND FUMES FROM HEAVY METALS. Combine it with the other tools and documents (as described above) and **increase awareness** and make it possible to **discover hazards**. All you need to do with your team is focus and have an open conversation with each other.

IMPORTANT ANNOUNCEMENT!

Dear Users,

From 1 January 2021, the validity date of the HSElife NL training courses will be adjusted!

All training courses placed in HSElife NL that are obtained **as of 1 January 2021** will have a validity of 2 years (this was 4 years). As an User you do not have to take any action yourself. The LARS registration system registers your completed training courses and automatically sends you a reminder e-mail one month before the expiry of the validity period (2 years). You then have the possibility to re-accomplish the training(s) free of charge. Incidentally, this only applies to users who are going to do work or are already doing work for one or more companies affiliated with NOGEPA. If you do not take the training courses again, these courses will automatically be removed from the LARS system after the expiry of your validity date.

This training validity change **does not apply** to the training courses that are placed in the Company/Contractor specific sites on the HSElife NL website. The period of validity of the training courses in question is indicated separately here.
