LITHIUM-ION BATTERIES

As a part of our yearly activities, in cooperation with the NOGEPA Workgroup, we are proud to present the latest addition in the HSElife NL Health, Safety and Environment items library: LITHIUM-ION BATTERIES!

A **Lithium-ion battery** is a way to store energy and convert chemical energy into electrical energy. Lithium-ion batteries contain much more energy than a standard battery. This has many advantages, but also disadvantages.

If used incorrectly, a Lithium-ion battery can unexpectedly ignite or even explode. For example, by exposure to heat or contact with water.

But also by using non-original chargers, overcharging the battery or by damaging it. The gases are toxic. Do not inhale them. The number of incidents is increasing because more Lithium-ion batteries are being used.






INCREASE AWARENESS, IDENTIFY HAZARDS
